1. 28-51D, 4th sentence (Page 27)  
Insert "nonparty participant of right" between "parties" and "shall."  
Approved unanimously.
2. 28-51D, 5th sentence (page 27)  
Insert ",nonparty participants of right" between "The Panel" and "and the parties" and between "parties" and "cannot".  
Approved unanimously.
3. 28-51D, 6th sentence  
Insert language providing across the board inclusion of nonparty participants as a right in any mediation or conciliation.  
Approved by 8 in favor, 1 against
4. 28-51 Old D.2  
Provide language giving nonparty participants as a right to respond to notices of summary disposition.  
Unanimously approved.
