Dear President Gerberding:

In accordance with the new rules, the faculty has approved the Faculty Code amendments in Class "A" Bulletin No. 91 regarding Chapter 28 (Adjudicative Proceedings for the Resolution of Differences) and Section 25-71 (Standard of Conduct). The results of the election submitted to the faculty for vote on 1 June 1994 were:

1 body to commence an appeal, or within 10 days after a final order has been served on the parties,
2 whichever is applicable, any party may file a petition for reconsideration. Such petition shall be filed with
3 the person or persons issuing the final order and the Secretary of the Faculty Senate and shall be served on
4 all parties. Such petition shall set forth the grounds upon which relief is requested. The petition shall be
5 disposed of by the same person or persons issuing the order, if reasonably available. The disposition shall
6 be in the form of a written order denying the petition, granting the petition and dissolving or modifying
7 the final order, or granting the petition and setting the matter for further hearing. The petition is deemed
8 denied if within 20 days from the date the petition is filed the person or persons issuing the final order has
9 not disposed of the petition or served the parties with notice specifying a date of disposition of the petition
10 and the Secretary of the Faculty has confirmed that the person or persons issuing the final order do not
11 intend to act on the petition.

12 EXECUTIVE COMMITTEE SUBSTITUTE AMENDMENT: Section F. was added by substitute
13 amendment adopted by the Executive Committee on October 11, 1993. This is a technical revision made
14 to clarify a right given to parties under the state APA.

14 SECTION 28-71
15 TIME DEADLINES

16 If a Hearing Officer, a Hearing Panel, the Chair of the Adjudication Panel, the Secretary of the
17 Faculty or any reviewing body shall fail to meet any of the deadlines set in this Chapter, such failure shall
18 not affect the validity of the procedure, or any decision resulting from an adjudication held pursuant to
19 this Chapter, unless the delay was unreasonable and unduly prejudicial to the interests of any party or
20 nonparty participant of right.

21 SECTION 28-81
22 AVAILABILITY OF THE RECORD

23 At the conclusion of the proceedings, the record of the hearing shall be maintained by the Secre-
24 tary of the Faculty and shall be available for review to persons or organizations not party to the proceed-
25 ings but having an interest therein, not inconsistent with the tenets of academic freedom and privacy
26 rights of the parties or persons involved, subject to the written approval of both the President and the
faculty member or members involved in the proceeding. Copies of any portion of the record previously
