Chapter 28 Adjudicative Procedures for the Resolution of Differences. This proposal has been under consideration by various faculty committees, the Faculty Council on Faculty Affairs, the Executive Committee and the Senate for the past three years. The current revisions prohibit a Dean from taking disciplinary action before a case has been adjudicated; streamlines the procedures; brings certain aspects of the code into compliance with the Administrative Procedures Act (state law) and addresses the appearance of unfairness to victims in cases of scholarly and scientific misconduct and sexual harassment.

Action: Review proposal and, if approved, return proposal to the Senate for the second and final reading.
