Continuation Meeting of 12 May 1994

The Faculty Senate met at 2:30 p.m. in 301 Gowen Hall on Thursday, 12 May 1994. Chair Ronald B. Dear presided.

CONTINUED DISCUSSION OF CHAPTER 28, Adjudicative Proceedings for the Resolution of Differences (proposed amendments to the April 14, 1994 version)

Professor Stewart introduced amendments submitted by an ad hoc committee composed of Professors Andrews, Aronson, Junker, Stewart and Vaughn.

Section 28-33.B and Section 28-33.D (Adjudication Panel and Hearing Panels) A motion was made that Section 28-33.B be changed as follows and that Section 28-33.D be deleted:

The Adjudication Panel shall be a standing committee consisting of (1) at least 24 members of the faculty, three from each Senate group as nominated by the Senate Executive Committee and approved by the Faculty Senate; (2) at least 6 student members selected by the ASUW and the GPSS, under procedures established by the ASUW and the GPSS in cooperation with the chair of the Faculty Senate, and approved by the Faculty Senate; (3) at least 6 staff members selected by the University Office of Staff Personnel, under procedures established by that office in cooperation with the various organizations representing university employees, and approved by the Faculty Senate. Faculty, student and staff members of Hearing Panels for specific cases are selected from the Adjudication Panel. During the selection and appointment process for the Adjudication Panel, the commitment of the university to affirmative action and the necessity of diversity in the decision making body shall be adhered to. The chair of the Adjudication Panel shall be nominated annually by the Senate Executive Committee from among the Adjudication Panel faculty members and shall be approved by the Senate. No department chair, school director, assistant dean, associate dean or dean shall serve on the panel. Faculty and staff Adjudication Panel members shall serve 3-year terms. Student Adjudication Panel members shall serve 1-year terms. Adjudication Panel members and the chair of the Adjudication Panel are eligible for reappointment except that in the event a Panel member has served two consecutive terms, such member shall be ineligible for reappointment for a period of three years.

Questions were asked to clarify the meaning of the changes. When concern was expressed that provision had not been made in the amendment for alternates, Chair Dear commented that, were Adjudication Panel alternates found to be necessary, it could be easily remedied by making amendments in the future. The motion was passed.

Section 28-33.E (Adjudication Panel and Hearing Panels) A motion was passed to amend this section as follows:

All Comprehensive Adjudications shall be heard by one Hearing Officer and a Hearing Panel composed of five members, except that in cases involving a nonparty participant of right who is either a student or a staff member, the Hearing Panel shall be composed of seven members.

Section 28-33.F(2) (Adjudication Panel and Hearing Panels) A motion was passed to amend this section as follows:

For any case with a nonparty participant of right who is either a student or a staff member, the five seven Hearing Panel members shall consist of three five faculty members of the Adjudication Panel, and two student members of the ~~student body~~ Adjudication Panel (in a case
